

## 2025 Membership Form

June 1, 2025 to May 31, 2026

Amesbury Attitash Lake Shores Improvement Association (AALSIA) began in the late 1940s as a private neighborhood beach association for the Lake Attitash Shores subdivision. The association is a membership association (501(c)(6)). Each year the members meet at the beginning of the summer to elect 9 board members who provide oversight. There are 2 categories of membership:

- Voting membership is for deed holders of property Attitash Lake Shore subdivision
- Nonvoting membership is for renters

Only members have beach privileges. Members can bring guests, or allow them short term use of the beach if they are in residence with the member, but only if they have filled out a request (on the website) and downloaded an authorization. The guest must have the authorization with them when they are at the beach. Passes are available for up to 1 week at a time and are limited to 3 passes during a season.

Membership dues are used to pay our taxes, maintain our beach property, secure appropriate legal protections, fund neighborhood activities at the beach, and other related uses as determined by the Board of Directors. A financial report is presented to the members at the annual meeting.

Members who do not pay dues forfeit their beach rights and privileges, as well as membership in AALSIA, and must remove all their personal property. Members must pay all balances owed for any reason before they can become a member.

AALSIA rules and policies are posted on the website, and members, their families, and guests are responsible for complying with them. The board has the authority to review violations, and depending on severity, take actions which may include, but are not limited to notice to comply, removal of property after 48 hours, or cancellation of membership.

Each year the Annual Meeting is held at the beach in May. Meeting dates are announced on the website ([AALSIA.org](http://AALSIA.org)), Signs are also posted at the kiosk at the bottom of First Street near the beach and the phone pole at the corner of First Street and Old County Road. Membership is from June 1, 2025 to May 31, 2026.

Access to the beach is through a remote controlled gate, which AALSIA issues only to paid Members

### **DUES AND FEES**

**Voting and Nonvoting members:** \$150/year

**Boat/Board/Vessels:** Depending on availability of space, you may be able to store your boat/board/vessel at the beach. To do so, you **must** submit an application for each vessel stored at the beach (attached, and see website). A representative of AALSIA designated by the Board will assign you space for your vessel.

Fees are payable by cash or valid check. We do not accept credit cards.
